Dear Madam Secretary:

Transmitted herewith for filing, pursuant to 4 CSR 240-3.020, 2.060(5) and 3.545(20), to accomplish a name change on behalf of Time Warner Telecom of Kansas City LLC, are the following:

(A) *A statement clearly setting out both the old name and the new name:*

The old name is Time Warner Telecom of Kansas City LLC.
The new name is **tw telecom of kansas city llc**.

(B) *Evidence of registration of the name change with the Missouri Secretary of State.*

(C) *Either an adoption notice and revised tariff title sheet with an effective date which is not fewer than thirty (30) days after the filing date of the application, or revised tariff sheets with an effective date which is not fewer than thirty (30) days after the filing date of the application.*

Time Warner Telecom Inc. has a naming license agreement with Time Warner Inc. which will expire on June 30, 2008. To change its name prior to the expiration of that agreement, Time Warner Telecom Inc. amended its Certificate of Incorporation effective March 12, 2008 to change its name to **tw telecom inc.** in preparation for a broader name and brand change that will be effective July 1, 2008. The company will continue to use and be known as Time Warner Telecom Inc., as its trade name, until July 1, 2008 and during this period will co-brand with **tw telecom** while completing necessary legal and regulatory requirements. The Company issued a press release on March 12, 2008 (see our website at www.twtelecom.com) and mailed a letter to all customers on the same date advising them of the name change, which is attached here as **Attachment C**. Customers will see a message on their April, May and June bills advising them of the name change.
