NOTICE OF IDENTITY AND CREDENTIALS OF STAFF EXPERTS

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), and pursuant to the March 15, 2010 order of the Missouri Public Service Commission (“Commission”), the Staff states as follows for its *Notice Of Identity And Credentials Of Staff Experts*:

1. On March 15, 2010, the Commission entered its *Order Establishing Investigatory Docket And Setting On-The-Record Proceeding* (“Order”) in this Case.

2. In its *Order*, the Commission established an April 6, 2010, date for an on-the-record proceeding, respecting the Staff’s Iatan 1 air quality control system (AQCS) environmental upgrades and Iatan common plant construction audit and prudence review.

3. The Commission further directed in “Ordered: 7.” that any party which intends to tender expert witnesses at the on-the-record proceeding should file a pleading disclosing the identity and biographical background of those experts no later than March 30, 2010.

4. In “Ordered: 8.” the Commission directed that the Staff should make available all Staff members who have participated in the audit. Given the presence of “Ordered: 8.,” it was unclear to the Staff whether “Ordered: 7.” was also intended to apply to the Staff. Out of an abundance of caution, the Staff has treated “Ordered: 7.” as applying to the Staff.

5. The Staff has previously identified Robert E. Schallenberg, Charles R. Hyneman, and Keith A. Majors as involved on a daily basis in the Staff’s Iatan 1 AQCS and Iatan common

plant construction audit and prudence review. They are the technical Staff responsible for the Staff's December 31, 2009 Report Of Staff Respecting Its Construction Audit / Prudence Review Of Environmental Upgrades To Iatan 1 And Iatan Common Plant. They are the technical Staff the Staff would offer to answer questions regarding the status of the Staff's construction audit/prudence review of the Iatan Project.

5. Attached as Appendix A is the biographical background and credentials of Robert E. Schallenberg, Charles R. Hyneman, and Keith A. Majors.

WHEREFORE the Staff provides its *Notice Of Identity And Credentials Of Staff Experts*.
