**NOTICE OF LATE FILING

**COMES NOW** undersigned counsel for the Staff (“Staff”) of the Missouri Public Service Commission (“Commission”) and for his Notice Of Late Filing and Motion For Leave To Late-File states:

1. On May 14, 2010, undersigned Staff Counsel filed a Motion To Extend Filing Dates For Briefs By Two Days from May 18, 2010 to May 20, 2010 for Initial Briefs.
