On January 23, 2017, Union Electric Company, d/b/a Ameren Missouri, the Commission's Staff, the Office of the Public Counsel, and the Missouri Industrial Energy Consumers filed a Joint Motion asking the Commission to extend the date for Ameren Missouri to file for review of its membership in the Midcontinent Independent System Operator, Inc. (MISO). The Missouri Joint Municipal Electric Utility Commission (MJMEUC) filed a response on February 1 in which it opposes the Joint Motion. On February 5, Ameren Missouri filed a motion asking to be allowed until February 21 to reply to MJMEUC's response.

Ameren Missouri's request for additional time to reply is reasonable and the Commission will grant that request.
