On August 30, 2011, the Missouri Public Service Commission issued an order opening an investigation into the cost of compliance with federal environmental regulations (copy attached). In this order, the Staff was directed to lead a working group to perform this investigation and draft a report. The report will be filed no later than May 1, 2012.

The first meeting for this working group has been scheduled for Wednesday, October 26 at the Governor Office Building, Jefferson City, Missouri. It is anticipated that each of the investor-owned utilities will present information at this meeting. Other participants will be provided an opportunity to make presentations.
