**ORDER OPENING A WORKING CASE TO REVIEW THE COMMISSION'S RULES  
RELATED TO COGENERATION**

The Commission is opening this working case at the request of its Staff to gather information and facilitate discussion regarding the possible amendment of its rules related to cogeneration. The specific rules under consideration are:

- 4 CSR 240-20.060 (Cogeneration);
- 4 CSR 240-3.155 (Requirements for Electric Utility Cogeneration Tariff Filings); and
- 4 CSR 240-20.065 (Net Metering).

As to each rule, Staff asks for comments regarding the effectiveness of the rule, suggested changes to the rule, and any other comments relating to the rule. The Commission does not intend to use this case to discuss any pending cases but will instead promote a general discussion of the effectiveness of the rules.

As this is not a contested case, anyone may file a comment without legal counsel. Intervention requests are not necessary to submit comments or view documents.

3. Interested parties are invited to submit comments by October 15, 2017.

4. This order shall be effective when issued.
