**ORDER PROVIDING NOTICE AND ESTABLISHING**  
**INTERVENTION DEADLINE**

On November 16, 2007, Osage Valley Electric Cooperative Association filed a motion asking the Commission to issue an order correcting a legal description contained in an addendum to a territorial agreement between Osage Valley and Aquila, Inc., d/b/a Aquila Networks-MPS. The Commission approved that addendum on January 26, 2006, but Osage Valley has recently realized that the legal description for certain property described in that addendum contains errors. Aquila concurs in Osage Valley's motion, and the Commission's Staff has indicated that it has no objection to the proposed corrections.

However, Staff points out that the City of Peculiar and Cass County may also be interested in this correction. Therefore, Staff recommends the Commission notify those entities of this filing and give them an opportunity to intervene, before acting on Osage Valley's motion.

The Commission will follow the recommendation of its Staff by providing notice of Osage Valley's motion to the City of Peculiar and Cass County, and will establish an intervention deadline.

**IT IS ORDERED THAT:**

1. The Commission's Data Center shall mail a copy of this order to the governing bodies of the City of Peculiar and Cass County, Missouri.

2. Any proper person wishing to intervene in this matter shall file an application to do so no later than December 24, 2007. Such applications shall be filed with:
