Missouri Department of Natural Resources' List of Experts

COMES NOW the Missouri Department of Natural Resources and respectfully submits this List of Experts.:

On February 16, 2007, the Commission issued an Order scheduling on-the-record presentations for April 25, 2007 for Case Nos. EO-2006-0493, EO-2006-0496 and EO-2006-0497. On-the-record presentations are also set for April 27, 2007 for Case Nos. EO-2006-0494 and EO-2006-0495.

On March 15, 2007, the Commission issued an Order establishing a procedural schedule for the on-the-record presentations requiring the parties to file with the Commission a list of any experts, and their biographical backgrounds, that the parties intend to tender for the on-the-record proceedings by April 6, 2007. The Commission's order also requires the identified experts to file position statements by April 13, 2007, outlining their positions on the applicability of the prior state action exemption to the adoption of the PURPA standards in each case and the reasons for supporting these positions.

The Department of Natural Resources submits the following expert for Case No. EO-2006-0494, Fossil Fuel Generation Efficiency Standard: Mr. John Noller, Energy Policy Analyst/Planner III with the Missouri Energy Center.

Biographical background of Mr. Noller:

Education: Bachelor of Arts in History, Wabash College, Crawfordsville, IN

Master of Arts in History, Stanford University, Palo Alto, CA

Master of Business Administration in Information Systems, University of Missouri-Columbia.

1994 to 1996 -- Research Analyst for Missouri, Department of Natural Resources, Energy Center. Work included analysis of state and federal data on Missouri utility generating sources, energy use and emissions.

1996 to Present -- Policy Analyst/Planner III for Missouri Department of Natural Resources, Energy Center. Mr. Noller participates in the Energy Center's interventions in utility integrated resource plan cases filed before the Missouri Public Service Commission. Work includes extensive review and knowledge of the Commission's Electric Utility Resource Planning rule, 4 CSR 240-22.010 to 240-22.080, developing the Energy Center's report on the utility's compliance with the rule and participating in the development of agreements among the parties. Mr. Noller participates in workgroup meetings with AmerenUE and other stakeholders in the development of its next resource plan to be filed in February 2008.

Mr. Noller served as the principal author of a comprehensive multi-year study of Missouri's options for limiting greenhouse gas emissions that included analysis of the environmental performance of a variety of established and emerging generating technologies; presented information on renewable or alternative generation sources in several MDNR pre-permit meetings with regulated entities and represented the Energy

Center in utility stakeholder groups that drafted Missouri's energy efficiency and renewable generation set-aside under the state's rules for implementing EPA's NOx SIP Call and CAIR rule; conducts analysis of Missouri utility data from state and federal sources for a variety of informational and policy purposes; conducts analysis of energy policies and prepares energy-related comments on draft environmental impact statements.
