ORDER DIRECTING NOTICE, SETTING AN INTERVENTION SCHEDULE AND DIRECTING FILING

On October 13, 2006, a group of electric service consumers, identifying its self as the "Citizens of Iron County, Northwest End of Reynolds County, Edgehill and Black Area" ("Citizens"), filed a request with the Missouri Public Service Commission for a change in electric supplier. Citizens are currently serviced by Union Electric Company d/b/a AmerenUE ("AmerenUE"), and their request is to revert back to service provided by Black River Electric Cooperative ("Black River"). Citizens maintain that Black River previously provided their electric service for a period of greater than 50 years. Citizens' request includes a signed petition bearing approximately 104 names, and five written complaints regarding the provision of service by AmerenUE.

The Commission determines that notice of this action should be given by the Commission's Data Center sending a copy of this order to AmerenUE, Black River and to the Department of Natural Resources of the State of Missouri. The Commission further determines that the Information Officer of the Commission should provide notice of this

order to the media serving Iron and Reynolds counties and to members of the General

Assembly representing the residents of iron and Reynolds counties.

The Commission shall direct AmerenUE and Black River to respond to Citizens'

request. The Commission shall also order its Staff to investigate the request and file a

report. As part of the Staff's report, the Commission specifically directs the Staff to

determine the reasons why Citizens originally changed their electric supplier from Black

River to AmerenUE.

IT IS ORDERED THAT:

1. The Missouri Public Service Commission's Data Center shall serve notice as

set out herein.

2. The Missouri Public Service Commission's information officer shall serve notice

as set out herein.

3. Any party wishing to intervene or to request a hearing shall do so by filing an

- 4. Union Electric Company d/b/a AmerenUE shall file a response to the request for a change of electric supplier filed by Citizens of Iron County, Northwest End of Reynolds County, Edgehill and Black Area no later than November 16, 2006.
- 5. Black River Electric Cooperative shall file a response to the request for a change of electric supplier filed by Citizens of Iron County, Northwest End of Reynolds County, Edgehill and Black Area no later than November 16, 2006.
- 6. The Staff of the Missouri Public Service Commission shall conduct an investigation into the request for a change of electric supplier filed by Citizens of Iron County, Northwest End of Reynolds County, Edgehill and Black Area and file a report on its investigation no later than November 27, 2006.

7. This order shall become effective on October 17, 2006.
