- 5. Due to the press of other Commission business undersigned counsel was unable to complete the Staff's filing by the June 18, 2008 deadline. Undersigned counsel apologizes to the Commissioners, the Regulatory Law Judge, AmerenUE and the other Parties.

6. The Staff does not request this leave to late-file the Staff Report to unduly delay these proceedings or to inconvenience the Commissioners, Regulatory Law Judges, AmerenUE or the other Parties. The Staff does not believe that AmerenUE or the other Parties will be prejudiced by this late filing.
