#### ORDER GRANTING LEAVE TO AMEND APPLICATION

Issue Date: December 20, 2022 Effective Date: December 20, 2022

On October 5, 2022, the City of Butler (Butler) and Osage Valley Electric Cooperative (Osage Valley) filed a *Joint Application* for an order approving a *Territorial Agreement* filed with the application.

On November 30, 2022, Butler and Osage Valley filed a *Joint Motion for Leave to Amend Application and Amendment to the Application*. In the motion, Butler and Osage Valley request leave to amend Exhibit 1 and Exhibit 4 to the *Territorial Agreement*. Exhibit 1 – maps of the corporate boundaries of Butler, representing the current electrical service area of Butler – would be amended to exclude a parcel inside the corporate boundaries of Butler that is currently served by Osage Valley. Exhibit 4 – a map of the exclusive service area of Osage Valley – would be amended to include that same parcel. The Office of Public Counsel agrees with the proposed amendment.

The Commission finds the motion reasonable and will grant it.

#### THE COMMISSION ORDERS THAT:

1. Butler and Osage Valley are granted leave to amend their *Joint Application* by amending Exhibit 1 and Exhibit 4 to the *Territorial Agreement* accompanying the *Joint* 

Application by replacing those original two exhibits with the amended exhibits attached to their Joint Motion for Leave to Amend Application and Amendment to the Application.

- 2. The Commission's Data Center shall send a copy of this order and a copy of the *Joint Motion for Leave to Amend Application and Amendment to the Application* in this matter to all parties in the following Commission cases: EO-2023-0039, EO-2023-0040, EO-2023-0041, EO-2023-0042, EO-2023-0043, EO-2023-0044, EO-2023-0045, EO-2023-0046, EO-2023-0047, EO-2023-0048, EO-2023-0049, EO-2023-0050, EO-2023-0051, EO-2023-0063, and EO-2023-0064.

# APPLICATION AND AMENDMENT TO THE APPLICATION

**COMES NOW** Osage Valley Electric Cooperative (Cooperative) and the City of Butler (City), as their *Joint Motion for Leave to Amend Application and Amendment to the Application*, in accordance with 20 CSR 4240-2.080(18), states as follows to the Missouri Public Service Commission (Commission):

1. On October 5, 2022, Cooperative and City of Butler filed an *Application for Approval of a First Territorial Agreement* ("*Application*") requesting approval of a Territorial Agreement designating the boundaries of exclusive service areas within portions of Bates County, Missouri.

#### MOTION FOR LEAVE

2. The *Application*, among other things, included as Exhibit 1 to the Territorial Agreement, a map of the exclusive service area of City and as Exhibit 4 to the Territorial Agreement, a map of the exclusive service area of Cooperative. After discussion, with Public Counsel, Cooperative and City believe that the Cooperative's service area map should be modified to include a parcel that is currently served by Osage Valley which is inside the city limits of the City of Butler and subsequently that the City's service area map should be modified to exclude said parcel. Accordingly, by this pleading, Cooperative and City seek the Commission's leave to amend their *Application* to include this issue as described herein.

3. Commission Rule 20 CSR 4240-2.080(18) provides, in part, that a pleading may be amended at any time by leave of the Commission. Cooperative and City believe that a grant of the requested leave will not prejudice the parties and will aid in the efficient processing of this

Application.

AMENDMENT TO THE APPLICATION

4. Cooperative and City provide the attached **Exhibit 1 – Amended** and **Exhibit 4 –** 

Amended and ask that the Commission consider this to replace and amend Exhibits 1 and 4 to the

Territorial Agreement.

WHEREFORE, Cooperative and City request the Commission issue its order granting

Cooperative and City's motion for leave to amend their *Application* and consider the *Application* 

amended as stated herein.




