ORDER SETTING DEADLINE FOR RESPONSES

On January 4, 2023, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively "Evergy") filed a request asking the Commission to grant it a variance from specific provisions of Commission Rule 20 CSR 4240-22.080 related to the filing of its annual resource plan update. On January 27, 2023, the Staff of the Commission (Staff) filed a recommendation to grant Evergy a one-time variance from the Commission's rule so it may file its annual resource plan updates on June 15, 2023.

The Commission will set a deadline for any responses to Evergy's applications or Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Any responses to Evergy's applications or Staff's recommendation shall be filed no later than February 6, 2023.
2. This order is effective when issued.
