On April 17, 2023, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro) filed its 2022 Renewable Energy Standard (RES) Compliance Report (“Report”) and its 2023 Annual RES Standard Compliance Plan (“Plan”), as required by Commission Rule 20 CSR 4240-20.100(8).

On May 31, 2023, in each of File Nos. EO-2023-0361 and EO-2023-0363, the Office of the Public Counsel (OPC) filed a *Request for an Extension of Time* in which to file comments on the Report and Plan. Evergy Metro does not object to OPC’s request.

The Commission will grant OPC’s request.
