SECOND NOTICE OF DEFICIENCY

Issue Date: August 21, 2023

On June 27, 2023, the Osage Valley Electric Cooperative Association (Osage Valley) and the City of Harrisonville, Missouri (Harrisonville) filed a Joint Application for approval of their Territorial Agreement (“Agreement”) pursuant to 20 CSR 4240-2.060, 20 CSR 4240-3.130 and Sections 394.312 and 416.041, RSMo.

Commission Rule 20 CSR 4240-4.017(1)(D) provides that a party may request a waiver of the 60-day notice requirement for good cause. Good cause may include “a verified declaration from the filing party that is has had no communication with the office of the commission within the prior one hundred fifty (150) days regarding any substantive issue likely to be in the case or that circumstances prevented filing the required notice and delaying the filing for sixty (60) days would cause harm.

In this case, the parties filed the required declarations that would support a request for waiver of Commission Rule 20 CSR 4240-4.017. However, the parties did not request a waiver of the rule. The Commission will not waive the Commission rule if it is not requested to do so. The Commission will not take action on Osage Valley’s and Harrisonville’s Agreement until this deficiency is corrected.
