

**CORRECTION OF ALGONQUIN'S RESPONSE**

COMES NOW Algonquin Water Resources of Missouri, LLC ("Algonquin") and, in order to correct its Response to Public Counsel's Application for Rehearing and Objection to Motion for Expedited Treatment, states as follows to the Missouri Public Service Commission (Commission):

1. On March 26, 2007, Algonquin filed its Response to Public Counsel's Application for Rehearing and Objection to Motion for Expedited Treatment.
2. In that Response, Algonquin made the following statement concerning the \$174,954 in rate case expense identified by the Commission's Report and Order - "actual invoices supporting the \$174,954 were admitted into evidence without objection. See Exh. 32 and 33."
3. That amount is supported by Exhibits 32 and 33 (as well as by the Surrebuttal Testimony of Staff witness Boateng (Exh. 16)). However, further review of the transcript in this matter reveals that Staff Counsel made an objection to the admission of this evidence that was overruled by the law judge (Tr. 488-491). I apologize for this error and any inconvenience this may have caused.


