**ORDER SUSPENDING THE PROCEDURAL SCHEDULE, CANCELING  
THE EVIDENTIARY HEARING, AND DIRECTING FILING**

On November 2, 2022, Evergy Missouri Metro and Evergy Missouri West (collectively “Evergy”) submitted a motion to suspend the procedural schedule. The motion states that the parties have reached an agreement in principle. Evergy requests that the Commission suspend the procedural schedule, pending the filing of a stipulation and agreement that would resolve the issues in this case. Evergy represents that the other parties do not object to this request.

The Commission will grant the motion to suspend the procedural schedule, cancel the currently set evidentiary hearing and order a status report.

**THE COMMISSION ORDERS THAT:**

1. The procedural schedule is suspended.
2. The evidentiary hearing scheduled for November 21-22, 2022, is canceled.
3. The parties shall file a copy of any agreement reached or a status report on this matter no later than December 1, 2022.
4. This order is effective when issued.
