**STAFF REPORT ON EVERGY MISSOURI WEST'S  
2022 ANNUAL RENEWABLE ENERGY STANDARD COMPLIANCE PLAN**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff") and for its *Staff Report on Evergy Missouri West's (EMW's) 2022 Annual Renewable Energy Standard Compliance Plan* respectfully states as follows:

1. On April 15, 2022, Evergy Missouri West, Inc. d/b/a Evergy Missouri West ("EMW" or "Company") filed its 2022 Annual Renewable Energy Standard ("RES") Compliance Plan ("Plan") as required by Commission Rule 20 CSR 4240-20.100(8).

2. On April 18, 2022, the Commission ordered Staff to file its report no later than May 31, 2022.

3. On May 23, 2022, Staff requested an extension to file its report on July 15, 2022, in order to give EMW time to respond to additional data requests from Staff and allow Staff the necessary time to analyze and incorporate EMW's responses in its report. This extension was approved by the Commission, and on July 1, 2022, EMW provided a Revised Plan to Staff.

4. On July 14, 2022, Staff requested an extension until August 5, 2022, to prepare its recommendation once the Revised Plan was filed by EMW. This extension was approved by the Commission on July 15, 2022, and on July 25, 2022, EMW filed its Revised Plan.

5. Rule 20 CSR 4240-20.100(8)(B) specifies the minimum required information the utility must provide in its annual RES Compliance Plan.

6. Staff has conducted its review of EMW's Revised Plan as discussed in detail in the attached Memorandum, heretofore known as Attachment A, and states that the Company has met the minimum requirements of 20 CSR 4240-20.100(8)(B).

**WHEREFORE**, Staff submits its report for the Commission's information and consideration.
