# ORDER APPROVING TARIFF SHEETS IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: February 24, 2023

Effective Date: March 17, 2023

On January 15, 2023, the Commission issued its Report and Order approving a stipulation and a territorial agreement between Co-Mo Electric Cooperative and Union Electric Company d/b/a Ameren Missouri. The Report and Order required Ameren Missouri to file compliance tariff sheets describing the modification of its service territory which include a metes and bounds legal description of the affected parcels. On February 15, 2023, Ameren Missouri filed revised tariff sheets, Tracking No. YE-2023-0153, with an effective date of March 17, 2023, to comply with the Report and Order.

The Commission ordered its Staff (Staff) to file a recommendation regarding the compliance tariff sheets and set a time for any other responses to the compliance tariff sheets. On February 23, 2023, Staff recommended the Commission approve the compliance tariff sheets. No other responses were received. After reviewing the compliance tariff sheets and Staff's recommendation, the Commission finds that the tariff sheets comply with the Commission's Report and Order. So that Ameren Missouri can

implement the compliance tariff sheets on their effective date, the Commission finds it

reasonable to make this order effective in less than thirty days.

1. Ameren Missouri's compliance tariff sheets, Tracking No. YE-2023-0153,
