**ORDER GRANTING EXTENSION OF TIME TO RESPOND TO STAFF  
RECOMMENDATION**

Kansas City Power & Light Company (KCP&L) filed an application on February 27, 2018, asking the Commission to approve exemplar tariff provisions that would modify KCP&L's existing tariffs regarding estimated billing and budget billing. KCP&L subsequently filed those tariffs with a May 7, 2018 effective date. On March 30, Staff filed its recommendation advising the Commission to approve KCP&L's tariff. The Commission allowed any party wishing to respond to Staff's recommendation until April 6 to do so.

On April 4, Public Counsel filed a motion requesting an additional week to file its response. The Commission will grant that request.

**THE COMMISSION ORDERS THAT:**

1. Public Counsel's Motion for Extension of Time to File Recommendation is granted.
2. Any party wishing to respond to Staff's recommendation shall do so no later than April 13, 2018.

3. This order shall be effective when issued.
