KCP&L Greater Missouri Operations Company (GMO) filed an application on February 27, 2018, asking the Commission to approve exemplar tariff provisions that would modify GMO's existing tariffs regarding estimated billing and budget billing. GMO has not yet filed actual tariffs, but indicates it would like to file the exemplar tariffs in time to allow a new billing system to be implemented in May 2018.

Before considering GMO's application, the Commission will direct its Staff to file a recommendation regarding that application.
