INTERCONNECTION AND RESALE AGREEMENT

This Interconnection, Collocation and Resale Agreement ("Agreement"), dated January 27, 2010, is entered into by between MCC Telephony of Missouri, LLC, a Delaware corporation ("CLEC"), and CenturyTel of Missouri, LLC d/b/a CenturyLink, ("CenturyLink") to establish the rates, terms and conditions for local interconnection, local resale and the purchase of unbundled network elements for the state of Missouri. (CenturyLink and CLEC may be referred to individually as a "Party" and collectively as the "Parties").

NOW, THEREFORE, the Parties agree as follows:

1. INTERCONNECTION AND RESALE AGREEMENT

The Parties agree that the Agreement between the Parties shall consist of the Interconnection, Collocation and Resale Agreement between Socket Telecom LLC and CenturyTel of Missouri, LLC dated September 15, 2006 (the "Adopted Agreement").

All services provided under this Agreement will be consistent with the decisions of courts having jurisdiction over this Agreement, including but not limited to the decisions of the Court of Appeals and the United States Supreme Court.

2. PARTIES:

CLEC is hereby substituted in the Adopted Agreement for Socket Telecom LLC and CenturyLink shall remain as the other Party to the Adopted Agreement. Except as modified herein, the Agreement shall in all other respects reflect the same terms as the Adopted Agreement.

3. TERM:

This termination date of the Agreement is June 30 2011.


