- **SUBJECT:** Staff Recommendation to Approve Union Electric Company, d/b/a Ameren Missouri Proposed Tariff Sheets for approval of Efficient Electrification Program effective May 28, 2022.

Ameren Missouri Operations Filing

On March 10, 2021, the Commission approved a Unanimous Stipulation and Agreement allowing Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") to establish an efficient electrification pilot program. The Commission approved Tariff No. YE-2021-0194¹ to implement the pilot program.

On April 28, 2022, Ameren Missouri filed with the Commission two (2) tariff sheets², Tariff No. YE-2022-0251, which bears an effective date of May 28, 2022. The filing letter, which accompanied the tariff filing, states that the proposed tariff sheets implement paragraph 11 (Reporting Requirements) of the Stipulation and Agreement approved in this case. One specific follow up item is a requirement of the Stipulation and Agreement (Paragraph 11, bullet 5, found on page 5 that states:

"To the extent allowed by the available equipment and associated data, an analysis of any correlation of equipment usage with customer billing demands, system coincident peak loads as well as non-coincident peak loads, including equipment impact on customer loads during peak and off-peak periods.

- Within 30 days of the Commission's approval of this Stipulation, Ameren Missouri will communicate to Staff, OPC, and Renew Missouri the technical capabilities and associated costs related to the capture of equipment load data and customer load data.
- Based on that information, the Company, Staff, OPC, and Renew Missouri will determine what data, if any, can and will be provided to Staff, OPC, and Renew Missouri.

• If the acquisition of equipment that facilitates retention of charging data exceeds the cost of similar equipment by more than \$50, the Signatories will support a reasonably revised tariff increasing the incentives by an amount in the range of \$50 - \$500, with the overall budget remaining the same."

In order to comply with this requirement, Ameren Missouri added the language below to the tariff.

To increase knowledge of how efficient electrification measures impact the electric grid, the Company encourages customers to include data acquisition options in their purchase. If such capability is available but is not included in the standard equipment purchase, the Company may provide an additional incentive to cover documented costs of equipment and data acquisition processes of up to \$500 to the incentives listed in the table below. Customers receiving the additional incentive for data acquisition will be required to provide agreed-upon data as requested and documented by the Company through the application process.

Ameren Missouri stated that the revision listed above was consistent with the Stipulation and Agreement approved in case ET-2021-0020.

It should be noted that the 30 day timeline referenced above was not met by Ameren Missouri.

Ameren Missouri stated that "while the 30-day requirement in this section is long overdue, please note that to-date there have been no applications for this program and, therefore, no potential loss of load data collection opportunities. The program opened in August 2021 and has been available to customers via the Ameren Missouri website since that time. Marketing efforts have just begun to ramp up for the incentives under this program."³ Additionally, Ameren Missouri shared the proposed tariff sheets with Staff and OPC prior to filing.

The Commission issued its *Order Directing Staff Recommendation* on April 28, 2022, which directed Staff to file its recommendation no later than May 13, 2022, at 11:00 a.m. The Commission directed Staff to inform the Commission of whether the Company's tariff revision complies with both the Commission's order as well as the approved Stipulation and Agreement and set a time for other parties to comment.

Staff Recommendation

Staff has reviewed documents provided by Ameren, namely the quote on cost for data acquisition and output report (EPS Data quote and Full Cycle Report) and has verified that the revised tariff increasing the incentives is less than the \$500 threshold established in the Stipulation and Agreement, with the overall budget remaining the same. Based on the responses from Ameren Missouri, no data loss

resulted from Ameren Missouri missing the 30 day timeline referenced above, so Staff does not object to the delay in this instance. Aside from this delay, Staff agrees that the Efficient Electrification program tariffs are in compliance with the Stipulation and Agreement and the Commission Order.

The Commission Staff's Tariff/Rate Design Department has reviewed the filed tariff sheets and recommends the Commission issue an order approving the following tariff sheets, as filed on April 28, 2022, for service on and after May 28, 2022, the requested effective date:
