# ORDER CONCERNING EXHIBITS, MATTERS FOR OFFICIAL NOTICE, AND BRIEFING SCHEDULE

On May 26, 2021,<sup>2</sup> the Commission issued an Order Setting Procedural Schedule and Suspending Tariffs ("Procedural Order"). On September 21, the Commission issued an Order Concerning Evidentiary Hearing that gave all parties and witnesses the option of appearing and testifying virtually by WebEx at the evidentiary hearing.

The Procedural Order set this matter for an in-person evidentiary hearing on October 12 and 13 and set November 6 and 19 as deadlines respectively for parties' initial and reply briefs. The hearing in this matter, however, occurred virtually on October 12, 13, and 19, 2021. The Commission will amend the procedural order's briefing schedule and enter orders regarding exhibits and matters of official notice.

#### THE COMMISSION ORDERS THAT:

- 1. The parties' initial briefs in this matter shall be filed no later than November 12, 2021.
- 2. The parties' reply briefs in this matter shall be filed no later November 24, 2021.

3. No later than November 1, 2021, the parties shall file a joint list of all exhibits ("Joint Exhibit List"), as numbered at the evidentiary hearing, which were offered and received in evidence. To the joint exhibit list shall be added the following tariffs, duly numbered as an Evergy exhibit:

### Evergy Missouri Metro

- a. Residential Service, Schedule R, PSC MO No. 7, 10<sup>th</sup> version, Revised Sheets 5, 5A, 5B, 5C
- Residential Time of Use, Schedule RTOU, PSC MO No. 7, 1<sup>st</sup> version, Revised Sheets 7, 7A.

### Evergy Missouri West

- a. Residential Service, Schedule MORG, PSC MO No. 1, Original Sheets 146 through 146.2
- b. Residential Time of Use, Schedule MORT, PSC MO No. 1, Original Sheets 146.5 and 146.6.
- 4. No later than November 1, 2021, all exhibits duly numbered as set out in the joint exhibit list shall be filed in EFIS.
- 5. Any requests that the Commission officially notice any previous Commission orders shall be filed no later than November 1, 2021. Such requests shall contain as a marked exhibit the entire order in question but shall specifically identify all parts of such orders which the party wants officially noticed.
- 6. Any party wishing to offer as evidence the Non-Unanimous Partial Settlement Agreement from *In the Matter of the Application of Evergy Metro, Inc., Evergy Kansas Central, Inc. and Evergy Kansas South, Inc for Approval of Transportation Electrification Portfolio*, Docket No. 21-EKME-320-TAR, Before the State Corporation Commission of the State of Kansas, ("Kansas Agreement") shall do so by filing a request with the Kansas Agreement attached as a marked exhibit no later than November 1, 2021.
