AMENDMENT TO
INTERCONNECTION AGREEMENT

By and Between

SOUTHWESTERN BELL TELEPHONE, L.P. D/B/A SOUTHWESTERN BELL
TELEPHONE COMPANY

and

LOGIX COMMUNICATIONS CORPORATION

This Amendment to the M2A Interconnection (the "Amendment") is dated as of Dec 18th, 2002, by and between Southwestern Bell Telephone Company¹ ("SWBT") and Western Communications, Incorporated d/b/a Logix Communications (f.k.a. Logix Communications Corporation), with its principal offices at 2950 North Loop West, Suite 1200, Houston, Texas 77092 ("Western Communications, Inc d/b/a Logix Communications Corporation").

WHEREAS, Southwestern Bell Telephone, L.P. d/b/a Southwestern Bell Telephone Company and Logix Communications Corporation ("Logix Communications Corporation") are the parties to that certain "M2A" Interconnection Agreement dated as of March 9, 2001 (the "Agreement"); and

WHEREAS, Logix Communications Corporation has changed its name to "Western Communications, Incorporated d/b/a Logix Communications", and wishes to reflect that name change as set forth herein.

NOW, THEREFORE, in consideration of the mutual promises contained herein, Southwestern Bell Telephone, L.P. d/b/a Southwestern Bell Telephone Company and Western Communications, Incorporated d/b/a Logix Communications hereby agree as follows:


1. The Agreement is hereby amended to reflect the name change from "Logix Communications Corporation" to "Western Communications, Incorporated d/b/a Logix Communications."
2. Southwestern Bell Telephone, L.P. d/b/a Southwestern Bell Telephone Company shall reflect that name change from "Logix Communications Corporation" to "Western Communications, Incorporated d/b/a Logix Communications" only for the main billing account (header card) for each of the accounts previously billed to Logix Communications Corporation. Southwestern Bell Telephone, L.P. d/b/a Southwestern Bell Telephone Company shall not be obligated, whether under this Amendment or otherwise, to make any other changes to Southwestern Bell Telephone, L.P. d/b/a Southwestern Bell Telephone Company records with respect to those accounts, including to the services and items provided and/or billed thereunder or under the Agreement. Without limiting the foregoing, Western Communications, Incorporated d/b/a Logix Communications affirms, represents, and warrants that the OCN for those accounts shall not change from that previously used by Logix Communications Corporation with for those accounts and the services and items provided and/or billed thereunder or under the Agreement.

¹ On December 30, 2001, Southwestern Bell Telephone Company (a Missouri corporation) was merged with and into Southwestern Bell Texas, Inc. (a Texas corporation) and, pursuant to Texas law, was converted to Southwestern Bell Telephone, L.P., a Texas limited partnership, doing business as Southwestern Bell Telephone Company ("SWBT").

3. Once this Amendment is effective, Western Communications, Incorporated d/b/a Logix Communications shall operate with Southwestern Bell Telephone, L.P. d/b/a Southwestern Bell Telephone Company under the "Western Communications, Incorporated d/b/a Logix Communications" name for those accounts. Such operation shall include, by way of example only, submitting orders under Western Communications, Incorporated d/b/a Logix Communications, and labeling (including re-labeling) equipment and facilities with Western Communications, Incorporated d/b/a Logix Communications.
4. This Amendment shall not modify or extend the Effective Date or Term of the underlying Agreement, but rather, shall be coterminous with such Agreement.
5. This underlying Agreement is the result of CLEC's decision to opt into the M2A or parts thereof pursuant to Missouri Public Service Commission Order in Case No. TO-99-227 (dated March 6, 2001). This Amendment to such Agreement addresses certain specific language changes thereto as agreed by SWBT and CLEC ("Agreed Changes"). The Parties acknowledge and agree that (i) all aspects of this Agreement except for the Agreed Changes were made available to CLEC only as a result of CLEC's decision to opt into the M2A or parts thereof pursuant to Case No. TO-99-227; and (ii) therefore, no aspect of this Agreement other than the Agreed Changes set forth in this Amendment may qualify for portability into Illinois under 220 ILCS 5/13-801(b) ("Illinois Law") or Condition 27 of the Merger Order issued by the Illinois Commerce Commission in Docket No. 98-0555 ("Condition 27"). The Parties further acknowledge and agree that the Agreed Changes shall only be considered portable into Illinois under the Illinois Law and Condition 27 if they otherwise qualify for portability under such Illinois Law or Condition 27.
6. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
7. This Amendment shall be effective upon approval by the Kansas Corporation Commission.


