On September 1, 2023, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed its application for approval of the accrual and funding of Wolf Creek Generating Station decommissioning costs at current levels. Evergy Missouri Metro requests the Commission accept its cost report, approve the continuation at current levels of the annual decommissioning expense accrual and trust fund contribution, and approve a change in the nuclear decommissioning trust (NDT) investment manager.

As Evergy Missouri Metro is not requesting a change in the current level already included in its retail rates approved in File No. ER-2022-0129, no new tariffs were filed. Before acting on Evergy Missouri Metro's application, the Commission will direct its Staff to file a recommendation.
