**STAFF RECOMMENDATION REGARDING
REVISED TARIFF SHEET**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), and through counsel, and states the following regarding the revised tariff sheet Spire Missouri, Inc., d/b/a Spire (“Spire”) filed, bearing an effective date of September 30, 2023.

1. On August 30, 2023, the Commission issued its *Order Granting Certificate of Convenience and Necessity* (“Order”) which granted Spire a certificate of convenience and necessity (“CCN”) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Johnson County, Missouri.

2. On August 31, 2023, Spire filed a revised tariff sheet with an effective date of September 30, 2023. On the same day the Commission issued its *Order Directing Recommendation on Revised Tariff* in which the Commission ordered Staff to file a recommendation no later than September 7, 2023, regarding Spire’s revised tariff sheet.

3. Staff reviewed Spire’s revised tariff sheet and determined that the following comply with the Commission’s *Order* and recommends approval:

WHEREFORE, Staff recommends that the Commission approve Spire's revised tariff sheet as listed in paragraph 3, above, to go into effect September 30, 2023.


