**ORDER RESETTING EVIDENTIARY HEARING**

The Commission held a prehearing conference on August 30, 2023. At that prehearing conference the Regulatory Law Judge informed the parties he would issue an order resetting the evidentiary hearing to October 6, 2023. Accordingly, the Commission will set an evidentiary hearing date for this complaint.

**THE COMMISSION ORDERS THAT:**

1. An evidentiary hearing is scheduled for October 6, 2023, beginning at 9:00 a.m. The hearing will be held virtually by telephone and videoconference via WebEx. WebEx meeting information will be emailed to the parties prior to the evidentiary hearing.
