On August 25, 2023, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed the above-referenced application. Liberty asks for expedited treatment, stating that there will be a temporary change in billing practices as early as September 18, 2023. Liberty also asks for a waiver of the Commission's 60-day notice requirement under 20 CSR 4240-4.017.

Liberty amended its application on September 5, 2023. On September 6, 2023, the Commission's Staff (Staff) filed a Status Report. Staff acknowledged the amended application, and stated that it plans to file its Recommendation by September 22, 2023.

The Commission will order its Staff to file a Recommendation or alternative pleading.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file a Recommendation or status report no later than September 22, 2023.
2. This order shall be effective when issued.
