On September 5, 2023, counsel for Metropolitan Telecommunications of Missouri, Inc. filed a letter with the Commission containing notice that it had converted to a limited liability company, resulting in a name change to Metropolitan Telecommunications of Missouri, LLC. Metropolitan Telecommunications of Missouri, Inc. was authorized by the Commission to provide interexchange telecommunications services in File No. XA-2005-0426, effective July 2, 2005, and to provide local telecommunications services in File No. CA-2005-0425, effective September 2, 2005.

The Commission will direct the Staff of the Commission (Staff) to file a recommendation regarding the notice.

THE COMMISSION ORDERS THAT:

1. No later than September 22, 2022, Staff shall file a recommendation regarding the notice filed by Metropolitan Telecommunications of Missouri, Inc.
2. This order shall be effective when issued.
