On May 18, 2023,¹ the Commission issued its *Report and Order Approving Addendum to an Existing Territorial Agreement (Order)*.

On September 7, Ameren Missouri filed a tariff sheet purporting to be in compliance with the Commission's Order. That tariff sheet was assigned Tracking No. JE-2024-0035 and has a proposed effective date of October 7.

The Commission will direct its Staff to review the tariff sheet and provide its recommendation. The Commission will also set a time for other responses.

THE COMMISSION ORDERS THAT:

1. No later than September 21, Staff shall file a recommendation as directed in the body of this order or a statement of when it expects to file its recommendation.
2. No other party is required to respond, but any party that wishes to respond to the tariff filings shall do so no later than September 25.
3. This order shall be effective when issued.
