ORDER CANCELING IVOIP REGISTRATION

Issue Date: September 12, 2023

Effective Date: October 12, 2023

On August 30, 2023, the Staff of the Public Service Commission (Staff) filed a motion advising the Commission to cancel the Interconnected Voice over Internet Protocol (IVoIP) registration of Strongcord Infrastructure Systems Management, LLC (Company) at that company's request. In its motion, Staff stated that the Company represents that it has no customers in Missouri. The Commission granted the Company its registration in File No. DA-2020-0150 on December 12, 2019.

On August 31, 2023, the Commission issued an order directing anyone wishing to respond to Staff's recommendation or request a hearing to do so no later than September 11, 2023. No responses were filed in response to Staff's motion.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and the Company's request, the Commission finds that the registration granted to the Company shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide IVoIP services granted to Strongcord Infrastructure Systems Management, LLC in File No. DA-2020-0150 is canceled.
2. This order shall become effective on October 12, 2023.
3. This file may be closed on October 13, 2023.
