ORDER RECOGNIZING NAME CHANGE

On August 4, 2023, MCImetro Access Transmission Services Corp ("MCImetro Corp.") d/b/a Verizon Access Transmission Services (Corp.) filed notice indicating they have changed their names to MCImetro Access Transmission Services LLC ("MCImetro LLC"). The company also filed tariff changes to adopt the new name. On August 28, 2023, the Commission's Staff filed a recommendation indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change.
