**ORDER APPROVING COMPLIANCE TARIFF SHEET**

On August 23, 2023,<sup>1</sup> the Commission issued its *Order Approving Application and Granting a Certificate of Convenience and Necessity* (Order) granting Spire Missouri Inc. d/b/a Spire a certificate of convenience and necessity (CCN) as an expansion of its existing natural gas distribution service area in Cass County, Missouri.

On August 24, Spire filed a tariff sheet purporting to be in compliance with the Commission’s Order. That tariff sheet was assigned Tracking No. JG-2024-0025 and had a proposed effective date of September 23.

Expedited at the Commission’s request, on September 7, the Staff of the Commission (Staff) filed its recommendation that the tariff sheet complies with the Order. Upon reviewing the pleadings, the Commission finds Confluence Rivers’ proposed tariff sheet complies with the Commission’s Order and will approve it. To enable the tariff sheet

to become effective on the date requested by Spire, the Commission finds it reasonable to make this order effective in less than 30 days.
