# ORDER DIRECTING RESPONSE REGARDING SETTLED ISSUE

Issue Date: September 13, 2023 Effective Date: September 13, 2023

On August 29, 2023,<sup>1</sup> Staff filed a *Unanimous Partial Stipulation and Agreement* (First Agreement). On September 1, Staff filed a *Nonunanimous Partial Stipulation and Agreement* (Second Agreement). The Commission cannot locate any reference to the settlement of Issue 21,<sup>2</sup> Corporate Allocations. It is not listed as an issue resolved in either Agreement, which is contrary to the Commission's understanding that Issue 21 was resolved by settlement.

The Commission will direct the parties to verify whether Issue 21 was included as a settled issue, the terms of that settlement, and where in the record those terms are expressed.

# THE COMMISSION ORDERS THAT:

- 1. The parties shall file a response, jointly if possible, to the concerns expressed in the body of this order no later than September 26.
  - 2. This order shall be effective when issued.
