On August 16, 2023, Union Electric Company d/b/a Ameren Missouri filed the above-referenced request. Ameren Missouri also asks for a waiver of the Commission's 60-day notice requirement under 20 CSR 4240-4.017.

The Commission ordered its Staff to file a Recommendation no later than September 18, 2023. On September 13, 2023, Staff filed a Motion for Extension of Time.

Staff explains that it has issued several data requests, and that responses to those requests aren't due until September 27, 2023. To give Ameren Missouri time to respond, and to give time for Staff to analyze the responses, Staff requests for an extension of time to October 16, 2023, to file its Recommendation.

The Commission finds the request reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. The Motion for Extension of Time is granted.
2. The Staff of the Commission shall file a Recommendation no later than October 16, 2023.
3. This order shall be effective when issued.

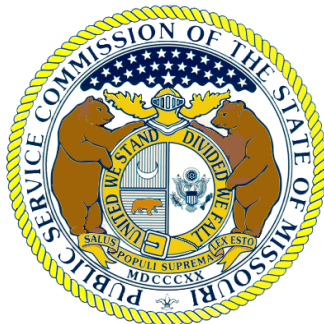
