On June 15, 2023, Evergy Missouri Metro, Inc. d/b/a Evergy Missouri Metro filed its 2023 annual update of the Integrated Resource Plan that it first presented to the Commission in its 2021 triennial IRP filing in File No. EO-2021-0036. Evergy Missouri Metro filed its IRP Annual Update Summary Report on July 14, 2023.

As permitted by Commission Rule 20 CSR 4240-22.080(3)(D), the Commission's Staff, Sierra Club, Renew Missouri, the Council for the New Energy Economics, the City of Kansas City, and the Office of the Public Counsel filed comments about that report. The Commission will direct Evergy Missouri Metro to respond to those comments.
