On August 23, 2023,¹ the Commission issued its Order Approving Application and

Granting a Certificate of Convenience and Necessity (Order) granting Spire Missouri Inc.

d/b/a Spire a certificate of convenience and necessity (CCN) as an expansion of its existing natural gas distribution service area in Cass County, Missouri.

On August 24, Spire filed a tariff sheet purporting to be in compliance with the Commission's Order. That tariff sheet was assigned Tracking No. JG-2024-0025 and had a proposed effective date of September 23.
