ORDER DIRECTING STATUS REPORT

On January 25, 2023, the Commission issued an *Order Approving Acquisition of Assets and Granting Certificate of Convenience and Necessity* (CCN) in this matter, to be effective on February 24, 2023. The order granted Spire Missouri Inc. d/b/a Spire, a CCN to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in and around the City of Oronogo in Jasper County, Missouri, as a further expansion of its existing certificated area.

On June 26, 2023, Spire filed a letter with the Commission regarding proposed modifications to its tariffs sheets. The letter indicated that the proposal was given to the Staff of the Commission (Staff) to review.

The Commission will now request a status report from Staff and allow any other parties to file a response.

THE COMMISSION ORDERS THAT:

1. Staff shall file a status report on this matter, including any actions requested of the Commission, no later than September 28, 2023, or request an extension of time to file its report.
2. Any other party wishing to respond to this order may do so no later than September 28, 2023.
3. This order shall be effective when issued.
