**ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH  
COMMISSION ORDER**

Effective Date: April 1, 2012

On March 15, 2012, Missouri-American Water Company ('MAWC") filed tariff sheets to be in compliance with the Commission's March 7, 2012 "Order Approving Non-Unanimous Stipulation and Agreement." The submitted tariff sheets, pursuant to the approved Agreement, bear effectives date of either April 1, 2012 or June 3, 2012, depending on the affected water or sewer district. MAWC further requests the cancelation of tariff books St. Louis County- P.S.C. MO No. 6, Jefferson City - P.S.C. MO No. 3, Missouri Cities - P.S.C. MO No. 4, Joplin- P.S.C. MO No. 2, St. Joseph- P.S.C. MO No. 1, and Warren County Water - P.S.C. MO No. 7. MAWC seeks expedited treatment; consequently, the Commission set an expedited response date.

On March 19, 2012, the Commission's Staff filed a recommendation that the Commission approve the compliance tariffs. No other party filed a response or objected to approving the tariff sheets. The Commission has reviewed the tariff filings and Staff's verified recommendation and finds the tariffs should be approved.

**THE COMMISSION ORDERS THAT:**

1. Missouri-American Water Company's request for expedited treatment is granted.
