On September 14, 2023,¹ The Raytown Water Company filed tariff sheets which were assigned Tracking No. JW-2024-0039. The tariff sheets bear an effective date of October 29.

The filing of the tariff sheets follows the filing of the Non-Unanimous Agreement Regarding Disposition of Small Utility Company Revenue Increase Request (Agreement) on September 13. The Agreement is pending approval and will be addressed in another order.

The Commission will direct its Staff to review the tariff sheets and provide its recommendation. The Commission will also set a time for other responses.

For the convenience of the parties, the Commission will restate the schedule as it remains in a staff-assisted rate case.
