SPIRE MISSOURI NOTICE OF FILING OF FINAL ACA BALANCES

COMES NOW Spire Missouri Inc. ("Spire Missouri" or the "Company"), by and through counsel, and respectfully submits this Notice of Filing of Final ACA Balances in the Spire East 2020-2021 Actual Cost Adjustment Filing case, stating the following:

- 1. On November 12, 2021, Spire Missouri filed revised tariff sheets with the Missouri Public Service Commission ("Commission") for the Spire East Purchased Gas Adjustment ("PGA"), for the 2020-2021 period, which reflected changes to its Actual Cost Adjustment ("ACA").
- 2. On December 15, 2022, Staff issued its recommendation. Staff proposed no adjustments to the Company's proposed ACA balances, and only had comments and non-financial recommendations on the Company's reliability and gas supply planning, actions during Winter Storm Uri, and hedging policies. Below were Staff's proposed ACA balances:

- 3. On January 19, 2023, Spire filed its response to Staff's recommendation, agreeing with Staff's recommendation and requesting the Commission establish the final ACA balances consistent with Staff's recommendation.
- 4. On January 27, 2023, Staff issued a reply to Spire Missouri's response, noting that the 2020-2021 Spire East ACA balances could not be finalized until the 2019-2020 Spire East ACA balances were established. GR-2021-0127, the docket for the 2019-2020 Spire East Actual Cost Adjustment Filing, had not been resolved at that time.
- 5. On August 23, 2023, GR-2021-0127 was fully resolved. In GR-2021-0127, Staff had recommended a disallowance of \$1,253,584, reflected in the chart above, related to an affiliated asset management agreement. Spire Missouri and Staff reached a partial stipulation to resolve this issue, agreeing to a disallowance of \$600,000. Below are the final Spire East ACA balances for the 2019-2020 period, approved by the Commission on August 23, 2023:
