On September 7, 2023, the Commission approve a Stipulation and Agreement. That order required Spire Missouri, Inc. (Spire) to file a compliance tariff.

Spire filed a tariff on September 15, 2023 in an effort to comply with the Commission’s order. The tariff bears an effective date of October 15, 2023. However, Spire asks for expedited treatment so that the tariff can go into effect by September 29, 2023.

The Commission will order its Staff to respond and will set a time for objections to the compliance tariff or motion for expedited treatment.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file a Recommendation, or an alternative pleading, no later than September 20, 2023.
2. Any other responses or objections to the tariff or motion for expedited treatment shall be filed no later than September 20, 2023.
3. This order shall be effective when issued.


