## ORDER OF RULEMAKING

By the authority vested in the Public Service Commission under sections 393.140, 386.250, and 386.266, RSMo 2016, the commission rescinds a rule as follows:

**4 CSR 240-3.161** Electric Utility Fuel and Purchased Power Cost Recovery Mechanisms Filing and Submission Requirements is rescinded.

A notice of proposed rulemaking containing the proposed rescission was published in the *Missouri Register* on July 2, 2018 (43 MoReg 1423-1424). No changes have been made in the proposed rescission, so it is not reprinted here. The proposed rescission becomes effective thirty (30) days after publication in the *Code of State Regulations*.

SUMMARY OF COMMENTS: The public comment period ended August 6, 2018, and the commission held a public hearing on the proposed rescission on August 13, 2018. The commission did not receive any written comments about the rescission, and no one offered a comment about the rescission at the public hearing.
