On March 20, 2023, Evergy Missouri West, Inc. d/b/a Evergy Missouri West filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file an application with the Commission for approval of a certificate of convenience and necessity authorizing it to purchase, own, operate, maintain and otherwise control and manage a generation facility. The Commission’s rule provides that if the application is not filed within 180 days, the noticed case shall close.
