On September 6, 2023, Chase Data Corp., pursuant to Section 392.550, RSMo, filed an application for registration to provide Interconnected Voice over Internet Protocol services (IVoIP) in the following exchanges:

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing within 60 days prior to the filing date of the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

This order will be issued with less than a 30-day effective date to comply with Section 392.550, RSMo.

1. Chase Data Corp. is registered to provide IVoIP services in the exchanges set forth in the affidavit attached to the application and restated above.

2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
3. This order shall become effective on September 29, 2023.
4. This file shall be closed on September 30, 2023.
