## NOTICE REGARDING INTERVENTION AND CONFIDENTIAL INFORMATION

Issue Date: September 20, 2023

The Commission opened this working docket to address non-residential rate design. The non-residential working docket will give all interested participants a collaborative opportunity to fully examine relevant factors, inputs, and outputs to ensure that future resulting rates are cost-based, equitable, and just and reasonable. The Commission referred several issues in Ameren Missouri's last two rate cases, File Nos. ER-2021-0240 and ER-2022-0337, to be examined within this working docket.

Intervention as a party is not necessary to participate in the working docket, but the Commission has found that the best way to make confidential information available for review by interested stakeholders is by allowing those stakeholders to intervene as parties. Intervening stakeholders are thus allowed to access confidential information to the same extent they would when they are granted party status in any other case. Any stakeholder that wishes to view confidential filings, will need to apply to intervene as a party.
