## ORDER WITHDRAWING PRIOR ORDER FOR STAFF RECOMMENDATION AND RESPONSES TO COMPLIANCE TARIFF FILING

On September 14, 2023,<sup>1</sup> The Raytown Water Company filed purported compliance tariff sheets which were assigned Tracking No. JW-2024-0039. The tariff sheets bear an effective date of October 29.

The filing of the tariff sheets followed the filing of the Non-Unanimous Agreement Regarding Disposition of Small Utility Company Revenue Increase Request (Agreement) on September 13. On September 15, the Commission ordered its Staff to review the tariff sheets and provide a recommendation – also setting a time for other responses to the tariff sheets.

However, the Agreement underlying the compliance tariff sheets was objected to by the Office of the Public Counsel on September 19. OPC has requested an evidentiary hearing.

Therefore, consideration of the compliance tariffs is not yet ripe, and the order directing a Staff recommendation and other responses will be withdrawn.
