ORDER APPROVING WNAR TARIFF

Issue Date: September 21, 2023

Effective Date: October 1, 2023

On September 1, 2023, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheets. The changes to the WNAR tariff sheets will adjust rates to account for the difference between actual heating degree days and normal heating degree days for the twelve-month period ending September 30, 2024.

On September 13, 2023, the Staff of the Commission (Staff) filed its recommendation. Staff reviewed the tariff sheets submitted by Liberty and recommended that the Commission approve them. On September 14, 2023, Liberty filed a substitute tariff to correct an error.

With this tariff filing, residential customers in Liberty's Northeast and West rate districts using 100 ccf in a given billing month will see an estimated \$3.05 increase in their bill from the current WNAR rate. For customers in Liberty's Southeast rate district, a residential customer that uses 100 ccf in a given billing month will see an estimated \$2.39

increase in their bill from the current WNAR rate. No other responses to the tariff sheets were filed in the time set by the Commission.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets should be approved. In addition, the Commission finds it reasonable to make this order effective in less than thirty days so that the order will be effective concurrently with the tariff sheets. Therefore, the Commission will approve these tariff sheets to become effective on October 1, 2023.

THE COMMISSION ORDERS THAT:

1. The following tariff sheets filed by Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty on September 1, 2023 (Tariff Tracking No. JG-2024-0033), as substituted, are approved to become effective on October 1, 2023:
