

**ORDER DIRECTING FILING**

On March 28, 2001, Union Electric Company d/b/a AmerenUE (UE or Applicant) filed an application requesting a variance from the individual metering requirement of 4 CSR 240-20.050(2) for a subsidized elderly housing project involving construction of two multi-unit residential buildings and one multi-use building supporting the project. The Volunteers of America St. Louis Affordable Housing Corporation is the project sponsor and developer.

The application is not in compliance with current rules and requirements of the Commission related to applications. Under 4 CSR 240-2.060(1)(K) the Applicant is required to inform the Commission of certain pending actions or judgments. The Applicant has not provided this information. Under 4 CSR 240-2.060(L) the Applicant is required to inform the Commission whether it has assessment fees or annual reports due the Commission. The Applicant has not provided this information.

In addition, 4 CSR 240-2.080 (19) requires proof of service on the Public Counsel and the Commission's General Counsel. UE provided proof of service on only the Public Counsel.

The Applicant must file a supplement to its application and a certificate of service correcting these deficiencies.

**IT IS THEREFORE ORDERED:**

1. That Union Electric Company d/b/a AmerenUE shall file a supplement to its application and a certificate of service as required no later April 16, 2001.

2. That this order shall become effective on April 2, 2001.
