ORDER APPROVING EXTENSION OF TIME TO FILE ANNUAL REPORT

On April 12, 2001, Union Electric Company d/b/a AmerenUE filed a request for an extension of time to file its 2000 annual report applicable to electric service. - 3. That when Union Electric Company d/b/a AmerenUE files its annual report applicable to electric service it shall attach a copy of this order to that filing.
 - 4. That this order shall become effective on May 3, 2001.
 - 5. That this case may be closed on May 4, 2001.
